1. The rental fee is **\$75.00 per school year and \$30.00 for the summer**. This fee will be payable at the time the student receives the instrument.
2. The instrument and the appurtenances are now and permanently the property of School District No. 91, Idaho Falls, Idaho.
3. **The described is to remain in my possession only during my membership in, or preparation for membership in a District 91 School Orchestra or Band, and as long as my rental fee is paid.**
4. A condition of my receiving this property, to which I subscribe with the approval of my parents, is that I shall try faithfully to perfect myself in the musical use of the same, and that I shall assist in all school functions that are undertaken by the orchestra or band, such as rehearsals, concerts and all other activities involving the musical organization of which I am a member.
5. I pledge myself to preserve the instrument and all appurtenances described in present condition, at any and all times, and when the term of my stewardship is ended, return said property to the owners in such condition. Such expense as is incurred in the fulfillment of this condition is borne by me, regardless of the cause of the injury to the instrument.
6. **I will not try to repair this instrument, nor employ anyone else to do so. If there is need of repair or adjustment, I will report the same to my music instructor, and contact the District Music Office for further instruction. In the event that I am responsible for repair of the damage (due to my negligence), the Music Office will advise me of the cost payable to them.**
7. In default of any or all of the provisions of articles 5 and 6, I shall be responsible financially for an equivalent in money for any damages to instrument or the destruction or loss of it.
8. I am enjoined from lending, renting or selling this instrument to anyone whomsoever. There are no exceptions to this condition except an order from the owners, School District No. 91, through its official representatives.
9. **If I withdraw from class or am asked to withdraw by my instructor or principal, the rental fee shall be forfeited and instrument returned to the Music Office immediately. \_\_\_\_\_ parent initial**
10. Unfortunately, state school transportation regulations do not allow cellos, double basses, and full-size tubas on the route busses. To help with this situation, a student may rent a second instrument at a discount to use for home practice. Second instruments will be available for check-out on October 20 of each school year.
11. **ALL DISTRICT INSTRUMENTS ARE TO BE RETURNED AT THE END OF THE SCHOOL YEAR FOR MAINTAINENCE AND INVENTORY. Any instrument not returned by the last day of school will be subject to a \$30.00 fee. \_\_\_\_\_ parent initial.** Students needing instruments for the summer or the 4<sup>th</sup> of July parade may check out instruments and pay the rental fee in June after maintenance and inventory is completed.
